

## **Indian Process Plant & Machinery Industry**

India having 3.28 million square kilometers land mass and 1.41 billion population is one of the fastest growing economy in the world.

The Indian process equipment & fabrication sector has solid foundation of over 50 years of experience and has contributed significantly to development of Indian Process Industry. The sector has large companies employing over 2000 persons. It also has a vibrant SMEs specialising in specific equipment or providing support products to the larger companies.

It designs and manufactures wide variety of equipment like regenerator, hydro-treaters, hydro-crackers, tubular reactors, towers, columns, shell & tube heat exchangers, plate type exchangers, finned tube exchangers, pressure vessels, centrifuges, furnaces, boilers. It is capable of manufacturing very large equipment like a regenerator 1200 Tonnes in weight or tower over 100 Meter long. It can shape plates over 225mm thick. It supplies skid mounted systems and modular plants.

It uses all kinds of materials of construction like alloy steel, aluminium, other non ferrous metals, plastics, FRP and so on. Lined equipment and piping (rubber, polymer & thermoplastics) is also manufactured in India.
